### APPLICATION FEE

A one-time, \$25 non-refundable application fee is charged for each new applicant to TPCS. This fee is paid during the online application process and does not apply toward tuition. The application fee for international students is \$150.

### DEPOSIT

A one-time, \$500 refundable deposit is collected for each new student enrolled at TPCS. This deposit is paid during the online enrollment process and is refundable upon graduation or with proper notice of withdrawal (see details in enrollment packet regarding withdrawal).

### PAYMENT OPTIONS

Payment plans for tuition begin in June for the following school year, with all payments due by May 31st of the applicable school year. Various payment options are available, including annual, monthly and semi-monthly. You will select your plan type during the enrollment process and that plan will remain in place for each successive year, although you can change your plan selection upon request. For international students, there is a \$5000 non-refundable down payment due upon completing the enrollment process. The remainder of the tuition balance is due by August 1st.

### FULL-PAY DISCOUNT

A 4% tuition discount is offered for any account paid in full by August 1st of the applicable school year.

### SEMI-ANNUAL PAY DISCOUNT

A 2% tuition discount is offered for any account paid in half by August 1st and the remaining balance by January 1st of the applicable school year.

### FINANCIAL AID

Tuition assistance is available for students demonstrating a financial need. Go to the FACTS website (<https://online.factsmgt.com/aid>) to apply for financial aid. TPCS participates in the Indiana Choice Scholarships (vouchers) program and the Scholarships for Education Choice (Sagamore SGO) program, and offers a limited amount of direct assistance. Families must re-apply for financial aid each year.

### LATE FEES

A 1% monthly service fee may be charged on all past due balances.

## 2022-2023 TUITION AND FEES INFORMATION

### INCIDENTAL EXPENSES

Expenses generally not covered by tuition include:

- Band instruments
- High school AP or dual-credit course fees
- Retreats and overnight field trips
- Athletic fees
- Lunch fees
- Before & After School Care
- Club fees
- Yearbook
- Lost or damaged library books or textbooks
- Lost or damaged school-provided Chromebooks or chargers
- Family Service Agreement Opt-Out fees or Unserved Hours fees

These types of expenses will be posted to your FACTS Incidental Fees account as they are incurred and will be due within 30 days or by the specified due date, whichever is later.

### NON-PAYMENT OF TUITION AND FEES

During the school year, any student with a past due balance may not be allowed to attend classes until the account is brought current. Any student with an outstanding balance from a prior year will not be allowed to start classes the following year. In addition, records will not be released for any student with an outstanding balance. Repeated incidents of non-payment may result in dismissal from TPCS. Each person with financial responsibility for a student will be responsible for any collection fees incurred.
